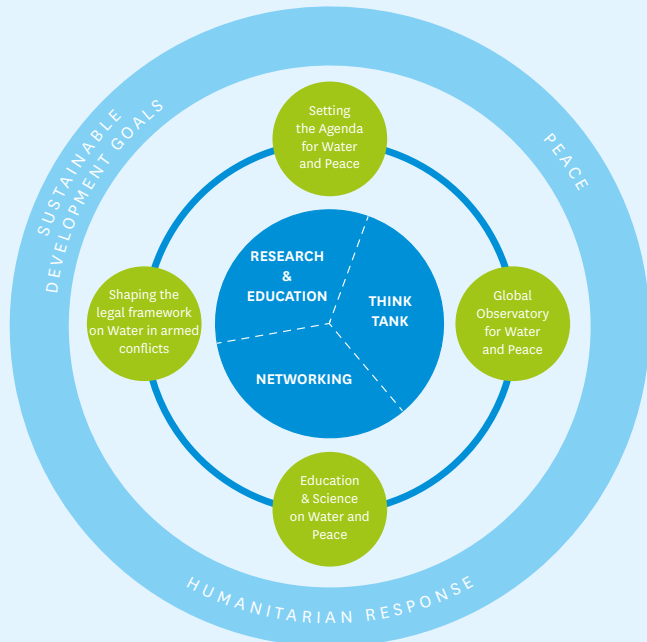

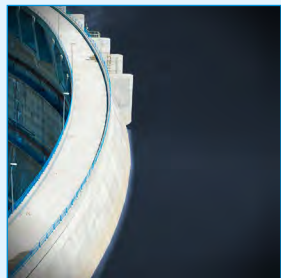
Online and certified courses

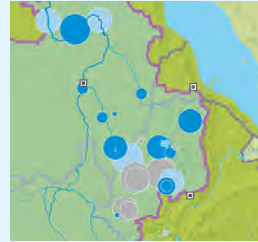
