## GLOBAL ALLIANCE TO SPARE WATER FROM ARMED CONFLICTS

### THE WEAPONIZATION OF WATER MUST STOP

Water should be the essence of life: nourishing and cleansing. But when warring parties weaponize water, civilians are deprived of their dignity and health.

The effects endure long after the dust has settled. Wells are poisoned and dams destroyed to flood communities and clear battlefields. Explosions put water treatment plants out of service and create public health hazards for months; contaminated water sources will take generations to clean up.

As Plato said: *only the dead have seen the end of war*. In this age of modern warfare, the growing trend of use and abuse of water must be reversed. **Water must be protected from war.**





## THE ALLIANCE?

Launched at the UN in New York in May 2024, the Global Alliance Sparing Water from Armed Conflict is a joint initiative of the Geneva Water Hub, the government of Slovenia and the government of Switzerland. The Alliance has an active membership of ministries of foreign affairs (Senegal, Jordan, Indonesia, the Philippines, Panama, Costa Rica, others? .) and key actors (UNICEF, PAX) active in the field.

The Alliance brings together lawyers, diplomats, engineers, politicians and social scientists from development, military, academic, and humanitarian communities; indeed all who are ready to reverse the trend of the weaponization of water, and protect water from all forms of armed conflict.


The Secretariat of the Alliance will coordinate international meetings, run the public relations campaign, and manage research and relations. The Secretariat will be staffed by one full-time Manager/secretary and one half-time Coordinator/public relations specialist. It will have the budget necessary to convene international meetings and run the public relations campaigns.



## HOW WILL THE ALLIANCE PROTECT WATER?

The end of the weaponization of water starts with understanding just how devastating and predictable are its consequences. The evidence we gather will strengthen domestic and international legal frameworks, feed public awareness campaigns, and influence high-level political processes. The Alliance will:

- **Generate and distribute knowledge about the reverberating effects** of armed conflict on water services;
- **Strengthen the legal frameworks of IHL and other law** offering protection of water, by furthering Geneva Principles on the Protection of Water Infrastructure, the Principles on protection of the environment in relation to armed conflict, and the ICRC Guidelines on the protection of the natural environment in armed conflict;
- **Shape political and legal processes** designed to influence the protection of water, by building on UN Security Council Resolutions 2417 (2018) and 2573 (2021), the Political Declaration on the use of Explosive Weapons in Populated Areas (2022);
- **Inform military training manuals** designed to progress protection of water;
- **Advocate publicly and behind-the-scenes** to make weaponization of water unacceptable; and
- **Build the capacity of state and non-state combatants and policy-makers** for all of the above.
